Content Pane

For the first container you add to the content pane, use the h1 container, for any further modules, use the h2 container.

Sub Headings

When adding content to the text / html module, you can add a sub heading using a h3, ie.

The module title is: welcome to my blog (using h1 or h2 container)

The first line of the text / html module (source code) is: <h3>by michael on october 31, 2006</h3>

The h3 tag places a yellow background around the text.

Right Pane

If you use the following text (source code) in tags it will create a yellow border around the content (right pane only):

<h3>a note, form, or ad</h3>

Logo

There are 2 versions of the skin:

- a) Displays the logo that you assign in the admin menu / site settings.
- b) Displays the text 'Freestyle' you can edit this text to suit your requirements by editing line 5 of the index.html file before uploading the skin.

Limitations

We recommend that you use the DNN-blue skin for the admin skin as the width of the content area is small and it will be difficult to read the admin sections of your DotNetNuke portal using the freestyle skin.
